Monthly Report

5/2/2016 12:19 PM Officer responded to the 500 block of E 1<sup>st</sup> Street for an unattended death. After speaking with the Medical Examiner it was determined that the elderly man had died of natural causes.

5/2/2016 9:30 PM Officer responded to a domestic altercation at the 10 block of Oak Blvd. The altercation was verbal and both parties agreed that they could cohabitate for the remainder of the night with no further problems.

5/4/2016 8:34 PM Officer stopped a vehicle on Highway 69 near Oak Blvd. The driver of the vehicle, a 21 year old Huxley man, was revoked from driving. He was arrested for Driving while Revoked and transported to the Story County Jail.

5/4/2016 10:40 PM Officer responded to an out of control teen call at the 800 block of 5<sup>th</sup> Ave. The officer was able to assist the family with no further problems for the remainder of the night.

5/6/2016 12:40 PM Officer responded to a parking lot at the 900 block of Highway 69 for a two vehicle accident. A vehicle operated by a Huxley man and a vehicle operated by a Slater woman failed to see each other as both were backing out of a parking spot and struck each other causing \$500 in damage.

5/27/2016 9:43 AM Officer received a complaint of a violation of a No contact order at the 300 block of E 5<sup>th</sup> Street. A Huxley man was receiving text messages from a 34 year old woman. Investigation continuing before an arrest warrant will be done.

5/28/2016 5:00 PM Officer responded to the 200 block of Centennial Drive for an out of control teen. The teen was eventually transported to Rosedale in Ames on a parental placement.

Huxley Officers had five arrests for the month. One was for Driving While Revoked, One for OWI, one for Driving Under Suspension, one for Possession of a Controlled Substance, and one for Possession of Drug Paraphernalia. Officer issued fifteen citations for traffic violations and gave seventy one warnings. Officers received 135 calls for service and had a total of 361 contacts for the month. Officers used 231.5 hours toward investigations or answering calls and gave 409 hours of general patrol.
