Monthly Report

4/5/2015 6:17 PM Officer took a complaint of Criminal Mischief at the 300 block of 2nd Ave. Eggs were thrown at a residence. Three juvenile boys admitted to throwing the eggs and were made to clean it up. Property owner declined charges.

4/8/2015 4:55 PM Officer was called to the 100 block of National Dr. to assist a parent with a teenager. The juvenile female was later taken to Rosedale in Ames and referred into Juvenile Court for Assault on a Police Officer and Interference with Official Acts.

4/10/2015 9:26 PM Officer stopped a vehicle for a traffic violation at Highway 69 and National Drive. The driver of the vehicle, a 21 year old Slater man, was arrested for Possession of a Controlled Substance and Possession of Drug Paraphernalia. He was transported to the Story County Jail in Nevada.

4/13/2015 6:00 PM Officer responded to a domestic altercation at the 100 block of Lynwood. A juvenile female and mother had gotten into an argument earlier but were able to cohabitate for the remainder of the night.

4/24/2015 2:28 PM Officer responded to a domestic altercation at the 100 block of National Drive. A 21 year old Huxley man was arrested for Domestic Assault and transported to the Story County Jail in Nevada.

Huxley officers had nine arrests for the month. Two were for Possession of a controlled substance, two were for Possession of Alcohol Under the Legal Age, one for Interference with Official Acts, One for Assault on an Officer, one for Possession of Drug Paraphernalia, one for Domestic Assault, and one for OWI. Officers issued 34 citations for traffic offenses and gave 87 warnings. Officers received 140 calls for service and had a total of 401 contacts for the month. Officers had 230.75 hours toward investigations, answering calls, or providing assistance and gave 466.5 hours of general patrol.
