Monthly Report

3/4/2016 8:25 AM Officer responded to a two vehicle accident at the intersection of Oak and Highway 69. A truck operated by an Ankeny man was stopped at the stoplights and was struck by a 53 year old Huxley woman from behind causing approximately \$6000 in total damage. No injuries.

3/4/2016 11:45 AM Officer arrested a 21 year old Huxley man for an arrest warrant out of Cass County. He was transported to the Story County Jail in Nevada.

3/10/2016 11:45 AM Officer responded to a theft call at Ballard High School. A phone was stolen sometime between 8:45 and 10:45 AM that day. No suspects at this time.

3/10/2016 4:00 PM Officer received a harassment complaint stemming from issues at the Ballard Middle School. Contact was made with a male Ballard student and parents who agreed to stop the behavior in order to avoid future police attention.

3/11/2016 12:49 AM Officer stopped a vehicle for a traffic violation on Highway 69 near Campus Drive. The driver of the vehicle, an Ankeny man, was arrested for Possession of a Controlled Substance and Possession of Drug Paraphernalia. He was transported to the Story County Jail in Nevada.

3/11/2016 5:15 PM Officer responded to a car vs. dog accident at the 300 block of E 3rd in Huxley. A vehicle being driven by a Huxley man struck a dog in the street. The dog is expected to make a full recovery.

3/14/2016 9:12 PM Officer stopped a vehicle for a traffic violation on Highway 210 near 560th. The driver of the vehicle, a 21 year old Ames man, was arrested for OWI and transported to the Story County Jail in Nevada.

3/18/2016 4:18 PM Officer stopped a vehicle for a traffic violation on Highway 69 near E 5th Street. The driver of the vehicle, a 30 year old Huxley man, was barred from driving. He was arrested for Driving While Barred and transported to the Story County Jail in Nevada.

3/26/2016 1:00 PM Officer responded to a two vehicle accident on 315th and 570th Ave. A vehicle operated by a 78 year old Minneapolis, MN woman struck a vehicle operated by an East Chicago, IN woman when attempting to enter 315th from 570th. No injuries.

3/28/2016 8:00 PM Officer was asked to perform a welfare check on a resident at the 200 block of N 3rd in Huxley. A 31 year old Huxley man was eventually transported to the Hospital for treatment.

3/29/2016 10:45 PM Officer responded to an altercation between two roommates at the 100 block of Oak Blvd. The altercation was verbal in nature and both agreed that they could cohabitate for the remainder of the night with no further problems.

Huxley Officers had seven arrests for the month. Three were for OWI, one was for Possession of a Controlled Substance, one for Possession of Paraphernalia, one for Driving While Barred, and one warrant served. Officers issued thirty four citations for traffic violations and gave 127 warnings. Officers received 170 calls for service or assistance and had a total of 465 contacts for the month. Officers used 263.25 hours toward investigations, answering calls, or providing assistance and gave 495.75 hours of general patrol.
